2022 Primary Election Overview

Voter Registration/Updates

An individual may register to vote at www.GoVoteKy.com through April 18, 2022. While the 'party change' deadline has passed for the 2022 Primary Election, revisions can still be made on addresses and name changes for registered voters during this time.

Mail-In Absentee Portal *(qualifiers in place)*

Qualifying voters may receive a ballot by mail through an application process. The application portal opens on Saturday, April 2, 2022 and closes on Tuesday, May 3, 2022. Log onto GoVoteKy.com to see if you qualify.

OFFICIAL BALLOT DROP BOX: Any voter with a mail-in absentee ballot may either mail their ballot in the envelope provided them or they may choose to drop their ballot into our Official Ballot Drop Box located in the lobby of the Scott County Courthouse at 101 E Main Street, Georgetown, KY. Voters may utilize the box between the hours of 8:30am and 4:30pm, Monday through Friday with the exception of Friday, April 15, 2022, as we are closed for the Good Friday holiday.

Walk-In Absentee Voting *'EXCUSED' (qualifiers in place)*

If a voter anticipates being absent during 'early' voting May 12-14, 2022 AND on Election Day, May 17, 2022, they may come into the Scott County Clerk's Office Elections Department, located on the 3rd floor of the Scott County Courthouse, 101 E Main Street and cast their ballot.

Early Voting *'UNEXCUSED' (no qualifiers in place)*

State legislation has allowed for 3 days of 'early' voting in the 2022 Primary Election. The Scott County Public Library located at 104 South Bradford Lane will house our 'Early' Voting Center. Thursday, May 12th, Friday, May 13th and Saturday, May 14th, the library will serve as a polling place for any eligible voter to cast a ballot in the Primary Election. The polls will be open during 'early' voting from 8:30am – 4:30pm all 3 days.

Primary Election Day *(Tuesday, May 17th)*

ALL PRECINCTS and the Vote Center at the Scott County Public Library, 104 S Bradford Lane will be open on Election Day, Tuesday, May 17, 2022 from 6am – 6pm.
